2. INVESTMENT

Your congregation's money will be invested in the Plan's RJV Stock Fund. The minimum investment is USD 18,000. Investments can be made by check, payable to the Reform Pension Board, or wire transfer. 3. FEES

The RJV Stock Fund investment management fee is a blended rate based on the fund's total pool of assets: 15 bps for the first \$10 million in assets and 10 bps for assets over \$10 million. For example, if the fund's value is \$20 million, the annualized fee is 12.5 bps. There is also an RPB administrative fee of approximately 24 bps.

4. ACCOUNT INFORMATION

RPB provides investors with access to account information and statements through InfoExpress, our recordkeeper's online portal. Your organization will receive one login to InfoExpress after we've processed this agreement and your check.

5. AUTHORIZED SIGNERS
